The Special Event permit RBC Fair Board requesting a liquor license for the RBC 4-H Livestock Sale on August 6th from 12:00 pm to 12:00 am at the 4-H Building located at 700 Sulfur Creek Rd. The public hearing has been posted and advertised; permission has been granted from Rio Blanco County and staff recommends approval.

Mayor Pro-Tem Day asked for questions or concerns. Trustee Gutierrez inquired why this application was late being turned in, Cook stated it must be posted ten days prior to the event and Mr. Shults met that deadline. Hearing no further discussion, Mayor Pro-Tem Day closed the public hearing at 7:10 pm and called for a motion to approve the Special Event Liquor License for RBC Fair Board 4-H Livestock sale on August 6, 2022. Moved by Trustee Nielsen. Second by Trustee Gutierrez. All ayes. Motion carried.

NEW BUSINESS

Donation request from Barone MS 6th Grade YMCA trip. Mrs. Teresa Anderson, a science teacher at Barone Middle School, started the 6th grade Outdoor Education trip eleven years ago and it has been a huge success. This program gives the whole class the opportunity to get better acquainted with classmates that would normally be out of their comfort zone, while building life coping skills such as tolerance and compassion for others. The students will be traveling to Granby, CO to study science, history, pioneering, among other subjects. This trip is funded entirely by donations, it was planned to accommodate fifty students, however there will be sixty-two students attending the 6th grade this year. With the increase in number of students and the cost of fuel, Anderson asked the board if they would be interested in donating \$1,500.00 to help fund this year's adventure. Hearing no further discussion Mayor Pro-Tem called for a motion to donate \$1,500.00 to the Barone Middle School 6th Grade YMCA Trip. Moved by Trustee Lockwood. Second by Trustee Gutierrez. All ayes. Motion carried. The Board requested the students do a presentation of their trip, Mrs. Anderson stated she would make sure that is accomplished.

Bid opening for sale of 2005 Ford Expedition. Mayor Pro-Tem Day stated there is one bid to open: Mrs. Suzanne Gerloff submitted a bid in the amount of \$1,605. The staff will review the bid and report back to the board at the August 23rd meeting.

Consideration of temporary Hotel Restaurant Liquor License for Powell Park Investments LLC. Town Clerk Cook stated Beth Ford was present representing Powell Park Investments. Beth Ford and her husband Richard are requesting a temporary hotel restaurant liquor license permit for MaFamilia Restaurant located at 410 Market Street. This would be allowing them one hundred twenty days to continue serving alcohol while they go through the application for the transfer of the license. Their application has been completed for both the temporary and the transfer. Town Clerk Cook is asking for approval of the temporary permit and to set the public hearing for the transfer for September 6th. Mayor Pro-Tem Day called for a motion to approve a temporary Hotel Restaurant Liquor License for MaFamilia Restaurant located at 410 Market Street. Moved by Trustee Lockwood. Second by Trustee Jehorek. All ayes. Motion carried.

OLD BUSINESS

Consideration of changes to SWCA Professional Services Agreement. Administrator Etheridge stated the ERBM Recreation & Park District Board looked over the agreement and approved with four modifications which include:

- Section 1.2.7 <u>General Contractor Bid Process</u> ERBM wants to add back into the contract the Project Management Committee and
- Section 1.2.8 <u>Construction Agreement</u> ERBM wants to add back into the contract the Project management Committee and
- Section 1.2.9 <u>Progress Reports and Attendance at Meetings ERBM</u> wants to add back into the contract *the Project Management Committee and/or*
- Section 2.1 <u>Industry Standards</u> ERBM wants to add back into the contract the Project Management Committee and /or
- Section 2.5 <u>Subcontractors</u> ERBM would like to delete this whole section; *CONTRACTOR* shall not knowingly comply or contract with an illegal alien to perform work under this contract and will verify immigration status to confirm employment eligibility. CONTRACTOR shall not enter into a contract with a subcontractor that fails to certify to Contractor that the subcontractor shall not knowingly employ or contract with an illegal alien to perform work under the Contract.

Attorney Massih suggested it would be best to keep Section 2.5 out of contract. Etheridge pointed out once again that the Project Management Committee will report to both the Town of Meeker and ERBM Boards if there is anything that is beyond what has been budgeted, and if any significant concerns arise. After a lengthy discussion Mayor Pro-Tem Day called for a motion to accept the four modifications made to the SWCA Professional Services Agreement. Moved by Trustee Gutierrez. Second by Trustee Nielsen. All ayes. Motion carried.

TOWN MANAGER'S REPORT

- Administrator Etheridge stated the Police Department will go live on Monday with their new records management software program. The staff has been in training for two weeks.
- Police Department got Officer Hetzel's vehicle fixed that was out of commission, and after an eighteen month wait the new truck that has been on order arrived, it will go to Officer Amick.
- There will be a Planning Commission meeting next Monday.
- The Chamber of Commerce is holding an open house next Thursday upstairs at Town Hall.
- Etheridge reminded the board of the workshop on August 13th at 6:00pm at the Rec Center. Agenda items will include presentation by Travis Day on the Water Measuring Project installation and the lease agreement between the Town and the Rec District for maintenance and operations of the parks. The Town is currently ten years into this twenty-year agreement during which time there have been three amendments incorporated into this agreement.

• The bulk water plant is under way with new installation of software. Communications with the public has been put out there in various forms making sure all customers are aware of the new keys being issued and that water will be shut down for two days. There has been some internet connection issues, however that should be resolved by end of day tomorrow.

The event was cancelled, Kindall was wondering what happened to the town's \$1,000.00 donation. Administrator Etheridge will get in contact with Clint Shults and find out. Trustee Lockwood reported the National Night Out sponsored by the Police Department was well attended. Trustee Jehorek stated the meals at the schools will be free this year, and possibly all the fall season activity fees for high school students will be paid for.
